### THAILAND, MALAYSIA & SINGAPORE PRIVACY POLICY FOR ADVENT PROGRAM

### 1. INTRODUCTION

SANOFI and its affiliates (each and collectively referred to as "SANOFI", "we", "our" or "us") commit to protect your personal data and your privacy and implements all necessary means to ensure such protection, in accordance with its Global Privacy Policy and applicable laws. This Privacy Policy ("Notice") will explain to you the purpose and the modalities by which SANOFI processes your Personal Data through this website. For the purposes of this Notice, "Personal Data" means any information relating to a person, which enables the identification of such person, whether directly or indirectly as defined by the applicable laws.

Your Personal Data collected through this website is processed under the control of GENZYME CORPORATION, 50 BINNEY STREET, CAMBRIDGE, MA 02142 U.S.A.

### 2. ON WHAT GROUND WE PROCESS YOUR DATA?

Unless stated otherwise, the communication of your Personal Data to SANOFI and the processing by SANOFI is mandatory for granting access to this website and the performance or the execution of the contract between you and SANOFI. Should you refuse to communicate your data, or your consent to SANOFI to collect, use, transfer, disclose or process your Personal Data, Sanofi will not be able to grant you access to this website.

## 3. TYPE OF DATA COLLECTED AND HOW DATA IS COLLECTED

Your Personal Data collected by SANOFI includes information about you that you give to SANOFI through this website, including upon completing the registration form, and though other interactions with SANOFI.

SANOFI may collect your Personal Data from different sources, including:

- Information that you communicate to SANOFI through various media and communication channels, whether verbally or in writing, or through direct or indirect interactions with SANOFI, such as your requests to SANOFI for information, your experience received from SANOFI's products and/or services, website, platforms, and cookies;
- Information that SANOFI collects, in accordance with the laws, from publicly available sources, such as data that is published by you; and
- Information that SANOFI legally obtains from third parties who are authorized to collect, use, transfer, disclose or process your Personal Data in accordance with applicable laws.

Your Personal Data will generally be provided by you directly. Certain personal data has been provided to SANOFI by the following third-parties: DOCCHECK, SWISSRX, AND MICROSOFT AZURE.

These entities have indicated to do so in the framework of their own privacy policies or by applicable law. If you want to learn more about the origin of such personal data and the condition of their collection and transfer to SANOFI, please refer to their applicable data protection policies.

### 4. FOR WHAT PURPOSES DO WE PROCESS YOUR DATA?

We collect, use, disclose, or process your Personal Data for the following purposes:

• On the basis of our contractual or pre-contractual relationship with you: TO ALLOW US TO IDENTIFY OR AUTHENTICATE YOU; PROVIDE OR VERIFY YOUR CREDENTIALS INCLUDING VIA PASSWORDS, PASSWORD HINTS, SECURITY INFORMATION AND QUESTIONS, HEALTHCARE PROFESSIONAL NUMBER. Providing this data is necessary to enter into a contract and to access to information available on this website; in case you fail to provide such data, you will not be able to use the services or access to this website;

TO PERSONALIZE YOUR EXPERIENCE WHEN USING OUR SERVICES; ENSURE THAT OUR SERVICES ARE PRESENTED IN THE WAY THAT BEST SUITS YOU; UNDERSTAND YOUR PROFESSIONAL AND PERSONAL INTERESTS IN OUR CONTENT, PRODUCTS AND SERVICES OR OTHER CONTENT AND ADAPT OUR CONTENT TO YOUR NEEDS AND PREFERENCES; PRESENT YOU PRODUCTS AND OFFERS TAILORED TO YOU;

TO ALLOW US TO COMMUNICATE WITH YOU; RESPOND TO YOUR REQUESTS OR INQUIRIES; PROVIDE SUPPORT FOR PRODUCTS AND SERVICES; PROVIDE YOU WITH IMPORTANT INFORMATION, ADMINISTRATIVE INFORMATION, REQUIRED NOTICES, AND PROMOTIONAL MATERIALS; SEND YOU NEWS AND INFORMATION ABOUT OUR PRODUCTS, OUR SERVICES, OUR BRANDS, OUR OPERATIONS; ORGANIZE AND MANAGE PROFESSIONAL EVENTS AND CONGRESSES, INCLUDING YOUR PARTICIPATION TO SUCH EVENTS;

TO CARRY OUT OUR BUSINESS OPERATIONS; CARRY OUT RELEVANCE OF EDUCATIONAL MATERIALS; RESPOND TO YOUR REQUESTS; TO KEEP TRACK OF OUR INTERACTIONS AND MEETINGS, SUCH AS WHEN YOU CONTACT US FOR INFORMATION AND SUPPORT;

- On the basis of legal obligations applicable to us and/or our activities: TO IMPLEMENT PHARMACOVIGILANCE PROCESSING;
- On the basis of our legitimate interests: TO IMPLEMENT PHARMACOVIGILANCE PROCESSING AND HEALTHCARE PROFESSIONAL VALIDATION; in this respect, you have the right to object to this data processing if you justify of a legitimate motive resulting from your particular situation.

### 5. WHO WILL HAVE ACCESS TO YOUR DATA?

As required for the above-mentioned purposes, SANOFI may need to communicate your Personal Data to the following recipients:

- AFFILIATES AND OTHER ENTITIES OF THE SANOFI GROUP IN CHARGE OF PROCESSING YOUR PERSONAL DATA UNDER SANOFI'S SUPERVISION AND INSTRUCTIONS;
- SUBCONTRACTORS AND SERVICE PROVIDERS IN CHARGE OF PROCESSING YOUR PERSONAL DATA UNDER SANOFI'S SUPERVISION AND INSTRUCTIONS.

SANOFI may also need to communicate your Personal Data to judicial and administrative authorities in accordance with legal or regulatory requirements and/or to respond to specific requests or orders in the framework of judicial or administrative procedures.

# 6. WHER YOUR DATA MAY BE TRANSFERRED?

SANOFI is a multinational Group. In this context, SANOFI may need to transfer your Personal Data towards entities of its Group. SANOFI may also need to share your Personal Data with third party partners outside of the SANOFI Group to process your Personal Data. Such SANOFI or non-Sanofi entities may be located outside the Economic European Area and/or outside Thailand, in countries where the legislation does not necessarily offer the same level of data protection or in countries not recognized by the European Commission or by the relevant authority in Thailand as offering an adequate level protection.

In order to ensure an adequate level of protection of your Personal Data, those transfers are safeguarded by SANOFI in accordance with the requirement of European law as follows including, notably SANOFI'S BINDING CORPORATE RULES FOR INTRA-GROUP TRANSFERS OF PERSONAL DATA IMPLEMENTED FOR PERSONAL IDENTIFICATION AND PHARMACOVIGILANCE PURPOSES OR THE EUROPEAN UNION MODEL CLAUSES (STANDARD CONTRACTUAL CLAUSES, CONTROLLER TO PROCESSOR).

You may obtain a copy of these safeguards by contacting our DPO (or LPO) hereinabove.

### 7. WHAT ARE YOUR RIGHTS?

In accordance with the rights granted to you by law, you are entitled to:

- access by simple request to your Personal Data in which case you may request to receive a copy of your Personal Data, unless such Personal Data is made available to you directly;
- to request a rectification of your Personal Data if such is inaccurate, incomplete or obsolete;
- to obtain the deletion, destruction or making unidentifiable of your Personal Data in the specific cases provided for by law;
- to withdraw your consent on the collection, use, disclosure, or processing of your Personal Data;
- to obtain your Personal Data we hold about you, in a structured, electronic format;
- to object to certain collection, use, disclosure or process of your Personal Data;
- to obtain a limitation of the processing of your Personal Data in the specific cases provided for by law;
- to receive your Personal Data for transmission to a third-party or to obtain the transmission of your Personal Data to such third-party as designated by you, to the extent this is technically possible.

Should a difficulty arise, you can send an information request directly to our Data Protection Officer at the following email address: PRIVACY-OFFICE-GLOBAL@SANOFI.COM. You can also lodge a complaint with the COMMISSION NATIONALE DE L'INFORMATIQUE ET DES LIBERTÉS or to the competent authority in Thailand where you believe our process of your Personal Data is unlawful or noncompliant with applicable laws.

## 8. STORAGE/RETENTION/DISPOSAL/DESTRUCTION OF DATA

SANOFI stores your Personal Data in secure operating environments, databases, and tools, which are only accessible to authorized SANOFI employees, agents and third parties. SANOFI undertakes to observe generally accepted industry standards and practices in the storage of your Personal Data or as required by the laws. SANOFI shall take the appropriate and reasonable, technical and organizational measures to ensure the required data security and to protect your Personal Data against unauthorized loss, access, use, modification, amendment, disclosure, deletion or processing. SANOFI shall require its employees, affiliates, and third parties who process your Personal Data to similarly comply with the legal requirements under this Notice and the applicable laws.

Your Personal Data will generally be retained for the following duration: FOR THE DURATION OF YOUR CONTRACTUAL RELATIONSHIP WITH SANOFI and in any case only for the duration that is necessary to fulfil the abovementioned purposes, unless further retention is necessary to meet legal or regulatory requirements or to the protection of SANOFI's interests. When your Personal Data is no longer required, SANOFI, and/or its Affiliate or agents shall destroy, delete or dispose of the same in a secure manner, following generally accepted industry standards and practices.

### 9. AUTOMATED DECISIONS

Certain personal data may be used as part of an automated analysis to be used by SANOFI to take a decision that concerns You. On the basis of this process, SANOFI may ON THE BASIS OF THIS ANALYSIS, WE MAY REFUSE TO GRANT YOU FULL ACCESS TO THIS WEBSITE.

This decision will be taken on the basis of DOCCHECK AND SWISSRX REGISTRATION. In any case, you have the right to request a verification of the validity of this decision through human intervention, to send us your observations and as needed, to contest the decision.
